 - 1. Death compensation: Up to 1,000,000 THB
 - 2. Medical expenses incurred abroad: Up to 100,000 THB
 - 3. Loss or damage to luggage or personal belongings: Up to 1,500 THB (Maximum of 500 THB per item/pair/set)
 - 4. Luggage delay compensation: Up to 2,000 THB
 - 5. Trip cancellation or rescheduling compensation: Up to 10,000 THB
